Ujala Cygnus has been a pioneer and champion of the Ayushman Bharat PMJAY initiative. All Ujala Cygnus are NABH accredited and are also empanelled with prominent TPAs and government panels, including ESI hence increasing their accessibility.

Ujala Cygnus hospitals are currently present in 18 districts and five states of Northern India reaching a population of over 5 crore people. In FY 22-23, Ujala Cygnus treated 3,42,656 inpatients, 4,59,891 outpatients and undertook 61,516 surgeries.
